**Responsibilities:**

Our Plymouth, MA project consists of a staff of five and is responsible for the operation and maintenance of the wastewater treatment plant and collections system, including remote pump stations. If you enjoy working outdoors protecting nature's precious resource, water, this position is for you. Candidates utilize basic mechanical and pumping equipment repair skills and have experience with electrical systems to provide maintenance and repair around the facility. Our operators participate in an "on call" rotation for plant coverage outside normal workday hours and shifts will include weekends. In addition, operators will be required to respond to emergency situations and work in inclement weather as needed.

**Qualifications:**

- Massachusetts Grade 4 or higher Wastewater Treatment Plant Operator License, preferred, or the ability to obtain through the operator's exam or reciprocity.
- 1-3 years' experience in a wastewater treatment facility, operation, and maintenance; or any equivalent combination of education.
- Experience in the operation and maintenance pumps, compressors, and plumbing fixtures.
- High School or trade school diploma is required, Associate's Degree preferred.
- A valid Massachusetts Class D motor vehicle operator's license.
- Knowledge of the hazards and safety precautions involved in wastewater treatment work.
- OSHA 10 Hour Construction Safety certification a plus.
- Knowledge of computer applications.
- Ability to read, interpret, and apply instructions, drawings, and specifications for work assigned.
