MassDEP has issued guidance for the removal of Asbestos-Cement Pipe (ACP). Employees working on the pipe must take training approved by the Department of Labor Standards to certify that they understand the proper safety protocols and acceptable work practices. Certification will need to be renewed every 5 years. This class will provide an understanding of:

- Types and uses of asbestos and identification of the material
- The nature of asbestos-related diseases and routes of exposure
- Applicable federal and state regulations regarding asbestos
- Proper techniques for cutting and removing ACP
- Pipe cutting demonstration and pipe wrapping hands-on activity
- Proper final visual inspection and waste disposal procedures
- Review of MassDEP's Guidance Document and related reporting forms

Attendees must successfully pass a multiple-choice exam to receive certification. Those completing this seminar will be awarded **5.5TCH**s. Credits approved for both MA water and wastewater operators as well as Rhode Island Water Operators

- 1. Take Mass. Turnpike Exit 10A
- 2. At end of off ramp take a left at the lights.
- 3. Go straight at the next set of lights.
- 4. Left at next set of lights on to Route 20 west.
- 5. Right on the next set of lights on to Nippnapp Trail.
- 6. Take the first right off Nippnapp Trail
- 7. Park in the lot on your left before the gate
- 8. Walk through the gate straight ahead to the Rick Alden Training Center
