

**8 HOUR OSHA CLASS II ASBESTOS TRAINING: ASBESTOS CEMENT PIPE WORKER SAFETY**

MassDEP has issued guidance for the removal of Asbestos-Cement Pipe (ACP). Employees working on the pipe must take training approved by the Department of Labor Standards to certify that they understand the proper safety protocols and acceptable work practices. Certification will need to be renewed every 5 years. This class will provide an understanding of:

- Types and uses of asbestos and identification of the material
- The nature of asbestos-related diseases and routes of exposure
- Applicable federal and state regulations regarding asbestos
- Proper techniques for cutting and removing ACP
- Pipe cutting demonstration(s) and pipe wrapping hands-on activity
- Proper final visual inspection and waste disposal procedures
- Review of MassDEP's AC Pipe Guidance Document and related reporting forms

Attendees must successfully pass a multiple choice exam to receive certification. Those completing this seminar will be awarded **5.5TCHs**. Credits approved for both MA Water and Wastewater operators as well as Rhode Island Water Operators.

**If you are heading South on Mass 91:**

From Mass 91, Take Exit 15. Right off ramp. Take a left onto Whitney Avenue at the light. Take the next right (right after the train tracks) onto Bobalo Road. Bobalo Road turns into Interstate Drive. Approximately 1 1/2 miles take a right onto William Franks Drive. (IKON/Arbella Insurance is on the corner of the street) If you miss the street and come to a stop sign-you've gone too far. ATC is located on the left. **Park and enter from the back of the building.**

**If you are heading North on Mass 91:**

From Mass 91, take Exit 15. Left off ramp. Take a left at the 2nd light onto Whitney Avenue. Take the next right (right after the train tracks) onto Bobalo Road. Bobalo Road turns into Interstate Drive. Approximately 1 1/2 miles take a right onto William Franks Drive. (IKON/Arbella Insurance is on the corner of the street) If you miss the street and come to a stop sign-you've gone too far. ATC is located on the left. **Park and enter from the back of the building.**

**From the East and West:**

From Mass 90 (Turnpike), take Exit 4 (West Springfield/Holyoke). Go towards Holyoke/Mass 91N, merge onto 91N. Get off at next exit #15. Left off ramp. Take a left at the 2nd light onto Whitney Avenue. Take the next right (right after the train tracks) onto Bobalo Road. Bobalo Road turns into Interstate Drive. Approximately 1 1/2 miles take a right onto William Franks Drive. (IKON/Arbella Insurance is on the corner of the street) If you miss the street and come to a stop sign-you've gone too far. ATC is located on the left **Park and enter from the back of the building**

**If you are on Riverdale Road (Route 5) heading North:**

Once you pass the Mass Pike Ramp entrance, you need to take a Left at the next light (there is a Dunkin Donuts on the corner) that is Highland Avenue. You will take your first left (Prospect Street). Stay on Prospect Street (go over Mass Pike, then under it). Take the Right after that onto Interstate Drive (there is an Ikon and Arbella Insurance on the corner) You will then take your first Left (this is William Franks Drive – it is not marked – there is a large K&M Electronics sign on the corner). The building is located on the Left. **Park and enter from the back of the building**

**If you are on Riverdale Road (Route 5) heading South:**

You will pass Providence Hospital and Brightside on the right. Dunkin Donuts is on the right at the light. Take a Right onto Highland Avenue. Take your first left onto Prospect Street. You will go over the Mass Pike and under the Mass Pike). Take the right after that onto Interstate Drive (there is an Ikon and Arbella Insurance Co. on the corner) You will then take your first Left (this is William Franks Drive – it is not marked there is a large K&M Electronics sign on the corner). The building is located on the Left. **Park and enter from the back of the building**
