**FROM EAST (BOSTON AREA)**: MA Pike (Route 90) West to Auburn Exit 10. Bear to the Right at end of ramp, South on Route 12 to Route 20 West. Continue on Route 20 West to Route 56 North. Follow Route 56 North for 7 miles to Route 9 West. Turn left at traffic light and continue for 1 mile. The Leicester Country Club entrance is on the right at the top of the hill across from Tractor Supply Store.

**FROM WEST (SPRINGFIELD AREA)**: MA Pike (Route 90) East to Sturbridge Exit 9 to Route 20 East 2 miles to Route 49. Travel Route 49 North for a distance of 7 miles to Route 9 East, take a right onto Route 9 east and travel for approximately 6 miles. The Leicester Country Club entrance is on the left as you travel down the hill and across from Tractor Supply Store.

**FROM SOUTH (CAPE COD AREA)**: Route 495 North to MA Pike (Route 90) Exit 22. West to Auburn Exit 10, bear to the Right at end of ramp, South on Route 12 to Route 20 West (1mi.). Continue on Route 20 West for a distance of 4 miles to Route 56 North. Follow Route 56 North for 7 miles to Route 9 West. Turn left at traffic light and continue for 1 mile. The Leicester Country Club entrance is on the right at the top of the hill across from Tractor Supply Store.

**FROM NORTH (LEOMINSTER AREA)**: Route 190 South towards Worcester, merge with Route 290 West to Exit 4 (Hope Ave.). Turn right at end of ramp onto Hope Ave., turn right at next intersection onto Webster Street, just after the Webster Street Fire Station turn left onto Mill Street, at the first set of traffic lights turn left onto Main Street and move into the right hand lane, travel straight through the next set of traffic lights Main Street (you should see signs for Route 9 West Leicester), travel approximately 3 miles. The Leicester Country Club entrance is on the right at the top of the hill across from Tractor Supply Store.
