- \* Experience in the operation and maintenance of pumps, compressors, and plumbing fixtures.

- \* High School or trade school diploma is required, Associate Degree or higher preferred.

- \* A valid Massachusetts motor vehicle operator's license.

- \* Knowledge of the hazards and safety precautions involved in wastewater treatment work.

- \* OSHA 10 Hour Construction Safety certification a plus.

- \* Knowledge of computer applications, and ability to use & learn various software programs [Hach WIMS, SEMS CMMS, and Utility Cloud].

- \* Ability to read, interpret, and apply instructions, drawings, and specifications for work assigned.

- \* Ability to establish and maintain effective working relationships with superiors, other personnel, and the general public.

- \* Ability to communicate effectively orally and in writing.

- \* Must be able to lift or move up to 40 lbs. on a regular basis.
